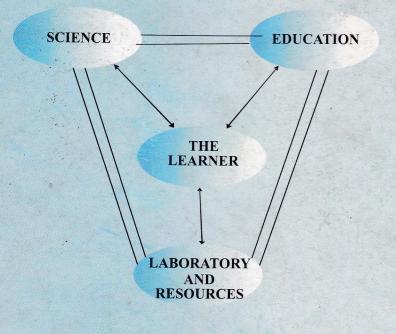

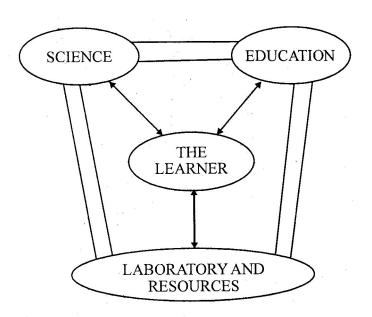

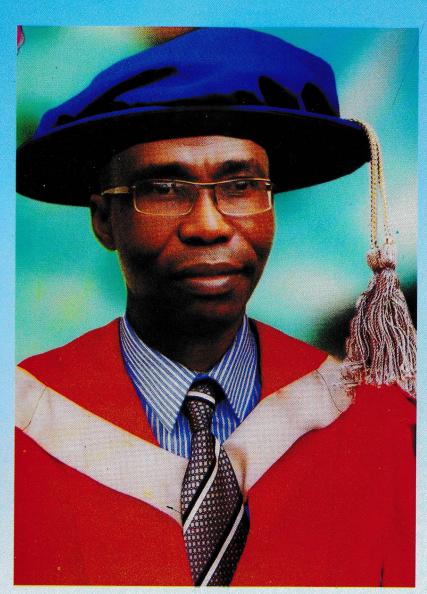

PROTOCOL

PREAMBLE

When I sent a memo to the Vice Chancellor in October 2012 indicating an interest to present an inaugural lecture, I prayed that I would be the first in the New Year. I thank God that this lecture opens the gate of 2013 for other inaugural lectures to come this year. I wish also to thank the management for the opportunities given me to present this lecture today and for making it the first this New Year.

It is worthy of note that today's lecture is the 36th in the series of Inaugural lectures in the University of Uyo, 8th from the Faculty of Education and 3rd from the Department of Science Education. By academic traditionally, an inaugural lecturer is expected to present to world the research works and experiences gathered over the years after ascending to the chair of Professorship, once in a life time.

I was promoted to this chair on October 2001 and I have waited for God's appointed day and time, which is now, to present this lecture. I have decided to pick the topic, **The ordeal of Science Teaching in the Contemporary Society: A need for paradigm shift for the new generation**, having taught science for several years and apparently dissatisfied with the way science is being taught in schools, colleges and the Universities.

1.0 INTRODUCTION

My interest in Physical Science started more prominently in secondary school. Then, three subjects were regarded as being very prominent and prestigious. They were Additional Mathematics, Mathematics and Physics, so we used to called them; Maths-Maths-Physics. I had good teachers in these subjects so I was highly encouraged to offer them.

After then, my late Dad exercised a great deal of influence on me urging me to join the Teacher Training College for a one year crash programme. As an obedient child, I obliged and there in the training college I fell in love with teaching as a profession, and from there my journey as a teacher started and now here I am a Science Teacher.

My experience over the years in Science teaching, especially in the contemporary society is that there is wide gap between the practice of science teaching then and now.

I will therefore look at:

- ✓ The practices of science teaching
- ✓ The existing gaps
- ✓ The consequences of the gaps
- ✓ The way forward

Before going far, let's consider some conceptual meanings of the key words in the topic as they relate to this lecture:

2.0 Concept of concepts

2.1 Ordeal:

This has to do with a prolonged painful or horrific experience. In this lecture, the ordeal means the prolonged painful and horrific experiences of science teachers and learners in the process of science teaching. These experiences have persisted for years unabated.

2.2 Science:

This is from a Latin word, scientia, meaning knowledge. It is a systematic enterprise that builds and organizes knowledge in the form of testable explanations and prediction about the universe (Abdullahi, 1982). The emphasis of science is on the universe, natural occurrences and natural events. The essence is to describe, explain and predict natural events and occurrences.

Furthermore, Science is seen as a body of knowledge that has been systematically acquired and made subject to further probing. This body of knowledge is not dogmatic or doctrinal; it is not a finality but changeable, amendable, falsifiable and questionable. In science, the emphasis is both on the process and the products. These two are said to be mutually related and inseparable. This mutual relationship should be recognized and utilized in any meaningful practice of science teaching. Teaching the product alone without the process or vice versa amounts to incomplete science.

2.3 Teaching

Teaching is different from Education, although a good relationship exists between the two. While Education connotes learning, teaching has to do with the processes leading to learning. It has to do with the pedagogy. It should be noted that teaching goes beyond what happens in the classroom/lecture room or laboratory. At all stages of education, the life of the teacher, his/her attitude, aspirations, knowledge of the subject humility, disposition, among others impact upon the learner directly and indirectly. For instance, if the teacher is always late in coming to class, students will gradually become late comers. The values upheld by the teacher are often silently transferred to the learners.

It should be noted that there exists a difference between **teaching** and **lecturing**. While the teacher is basically involved in the subject matter and the pedagogy, the lecturer is mainly after the subject matter. The goal of lecturing is to transmit knowledge and the research findings in the subject area, often without the knowledge of the learner.

On the other hand, a teacher goes beyond the subject matter to consider the possible way(s) the knowledge could be imparted to the learner to enhance optimum performance. This he does by selecting a teaching strategy that matches learners' background, aspiration, experience, intelligence, age, available resources, and the concept under consideration.

2.4 Science Teaching

There are three components of science teaching namely, process of science, product of science and teaching process.

a. Process of Science:

The processes of science are utilized to arrive at scientific facts, principles, laws, and generalizations. In order to solve scientific problems and arrive at the reliable and dependable solutions, the following processes are required (Onwioduokit, 2002).

- ✓ Observing and identifying problem (OBIP)
- ✓ Describing the observed problem (DOBP)
- ✓ Hypothesizing (HYPO)
- ✓ Experimenting (EXPT)
- ✓ Interpreting experimental results (INTER)
- ✓ Making conclusion and drawing inferences (MACD)
- ✓ Predicting (PRED) and
- ✓ Further experimentation

This is shown in a cyclic form as below:

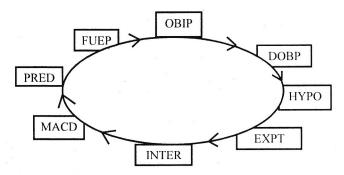


Figure 1: Some processes involved in solving scientific a problem.

While it could be said that the processes start with observation, it should be borne in mind that one can enter the cycle at any point provided that the pre-requisite processes are on course.

2.4.1 Scientific Process Skills

A skill is cleverness at doing something, resulting from either practice or natural ability. Scientific skills or science process skills, therefore, are skills needed to undertake meaningful scientific enquiry. They are mostly developed rather than being natural. The skills are expected to be inculcated in the pupils as they are guided through scientific processes.

There are many of such skills but they can be summarized them into five (5) as follows:

- ✓ Cognitive,
- ✓ Observational,
- ✓ Manipulative,
- ✓ Computational and
- ✓ Communicative.

A. Cognitive skill.

The skill contains variables such as:

- (i) logical reasoning;
- (ii) reflective (scientific) thinking;
- (iii) synthesizing;
- (iv) applying knowledge; and
- (v) creative thinking.

B. Observational skill.

This has to do with the following abilities:

- (i) using sense organs appropriately;
- (ii) observing changes in phenomenal effects as independent;
- (iii) recording of data (or other phenomena observed);
- (iv) detecting inconsistencies or contradictions; and
- (v) detecting common features or characteristics among objects or events.

C. Manipulative skill.

The sub-skills of manipulative skill include:

- (i) Handling of objects;
- (ii) Setting up apparatus;
- (iii) Modeling;
- (iv) Eye-Hand coordination;
- (v) Experimenting (manipulating variables); and
- (vi) Finger dexterity.

D. Computational skill.

This has to do with abilities required in:

- (i) Quantifying empirical concepts;
- (ii) Calculation on data obtained;
- (iii) Graph plotting;
- (iv) Making quantitative deductions; and
- (v) Being accurate in measurements.

E. Communicative skill.

The sub-skills involved here include:

- (i) Reporting;
- (ii) Questioning;
- (iii) Answering questions;
- (iv) Using appropriate language; and
- (v) Drawing conclusion.

It should be noted that the skills, though distinct, are related. Cognitive skill, for instance, is required in the proper exhibition of all other skills. Moreover, these skills should be assessed **on-the spot** using their performance codes.

2.4.2 Process skill's performance Codes

1. Cognitive skill

The following are the performance codes:

- (i) Ability to make sense out of what is observed;
- (ii) Knowledge of the science principles involved;
- (iii) Ability to relate one object or event with others;
- (iv). Ability to reason logically;
- (v) Ability to make good guesses;
- (vi) Ability to design experiments;
- (vii) Ability to apply the principles of science in solving problem(s) posed;
- (viii) Ability to deduce from the data or evidence at hand; and
- (ix) Ability to predict accurately.

For any given concept or activity, these codes can be used to assess how well a pupil possesses the cognitive skill. Each correct item could earn 10 marks initially, after which the relative weight is brought into consideration.

2. Observational skill's performance codes

- (i) Correctness of observation, that is, ability to observe correctly;
- (ii) Ability to discover characteristics features of objects or events:
- (iii) Ability to notice changes in characteristics in terms of say, colour, taste, smell shape, etc.
- (iv) Ability to notice the effect of one substance or object on the other (for examples, a vegetable oil makes a white paper translucent when robbed on it). Taking correct readings with measuring instrument;
- (v) Ability to detect inconsistencies or contradictions; and
- (vi) Ability to notice errors involved during experimentation.

3. Manipulative skill's performance codes

- (i) Ability to handle objects/apparatus correctly;
- (ii) Ability to set up apparatus correctly and with correct bearings;
- (iii) Ability to manipulate objects/apparatus correctly;
- (iv) Having good experimental posture;
- (v) Ability to have good eye-hand coordination
- (vi) Ability to construct models; and
- (vii) Ability to draw accurately

4. Computational skill's performance codes

- (i) Ability to relate the variables involved, quantitatively;
- (ii) Ability to get necessary data;
- (iii) Ability to summarize the data in a graphical form, if required;
- (iv) Ability to undertake all calculations required, accurately; and
- (v) Ability to assign correct units of measurement.

5. Communicative skill's performances codes

- (i) Ability to ask useful questions;
- (ii) Ability to answer questions;
- (iii) Ability to describe what is observed;
- (iv) Ability to use appropriate tenses in communicating;
- (v) Ability to report on the experiment;
- (vi) Ability to summarize the findings of scientific enquiry;
- (vii) Ability to discuss the findings; and
- (viii) Ability to communicate the conclusion.

b. Product of Science (Knowledge of subject matter)

This is very crucial in science teaching. No matter how versatile a science teacher is in the skills and knowledge of teaching strategies, if he/she does not have the right knowledge of the science subject then he is not a teacher of science. To have an excellent method of teaching with a wrong stuff is more dangerous than having a poor teaching method but a sound stuff.

c. Teaching process (Teaching Methods/ Strategies)

This is where the different exists between a science teacher and a science lecturer. A teacher teaches while a lecturer delivers lectures. The emphasis of the teaching is to get the students to understand, comprehend and apply the concepts taught. In doing this, he/she will plan effectively for the lesson, choosing appropriate strategies (considering lots of factors spanning from organismic to environmental), and making the learner the centre of all activities in the course of teaching. On the other hand, the science

lecturer is well vest with the subject matter and is basically interested in delivering the knowledge to the learner often without a careful consideration of the psychology of learning and information processing techniques.

It should be noted however that not all those who claim to be teachers are good teachers. Paper qualification, knowledge of how to teach and registration as a teacher does not mean much if these are not utilized in the classroom. There are science teachers even at the primary schools who are lecturing rather than teaching. This has been the ordeal.

3.0 Science Teaching in Nigeria.

3.1 Philosophy and Objectives of Science Education.

The fundamental objective of Science Education is to train science teachers who are academically and professionally capable of educating pupils, making them literate in sciences at all levels of educational system. Specifically, the purpose is to produce dedicated and reliable science teachers knowledgeable in all areas of science and skilled in teaching processes and classroom management, with a passionate desire to deliver the best to humanity.

Before independent in 1960, Science Education was still beclouded with "foreign" elements in the curriculum and non- utilization of teaching and learning aids. The laboratories (where available) were ill-equipped, in spite of the popularization Science Teachers' Association of Nigeria started giving to science from its inception in 1957. However, after the independence, science teaching started

to have a form of shape. When the Unity Schools came into existence in 1973, laboratories in those schools were well equipped and the teachers were well trained by the federal government. The progress in the teaching and learning of science continued from then with different missionary schools seeking to excel one another.

The down turn came into the teaching of science with the advent of community secondary schools. Although it was not a bad idea to encourage communities to run schools, most of such communities were only able to provide very limited infrastructural facilities and unable to equip the laboratories.

Another very serious setback the community schools brought was the Day-system of schooling which culminated in a breakdown of discipline in school. The adverse effects of these are still with us today.

3.2 Levels of Science teaching in Nigeria

Science is taught at the following levels:

- ✓ Primary level as Primary Science.
- ✓ Upper Basic level as Basic Science (formerly called Integrated Science)
- ✓ Senior Secondary Schools level as Physics, Chemistry and Biology.
- ✓ Science is taught at the Colleges of Education and Polytechnics
- ✓ Science is taught at the university level in four dimensions:
 - Pre-degree level
 - Basic studies level
 - Undergraduate level
 - Graduate level

At every level, there are demands and challenges for proper and effective teaching. I will like to say that of all the levels of science teaching, the Secondary School level (upper Basic Education and Senior Secondary) is most crucial. Although the primary level serves as the foundation, a skillful teacher at the secondary level can correct any wrong or poor foundation existing in the learner. Moreover, at this level a certain minimum grade is required for one to proceed to the tertiary level of science learning.

4.0 Global trend in Science Teaching.

Science and scientific research has reached an unprecedented stage in the nations of the world. Technology, which is the different ways scientific ideas and products are applied, has brought great comfort to man in all its ramifications. Science teaching all over the world has gone beyond the traditional classroom experience to a global world experience through the use of computers and e-learning facilities. It should however be emphasized that no electronic gadget can completely and effectively replace the teacher in the classroom.

4.1 Training of Science Teachers

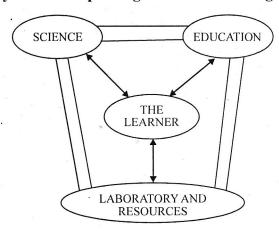
Training is a practical or vocational-oriented process that results in the acquisition of knowledge, skills and competence. Training has specific goals of improving one's capability, capacity and performance. It forms the core of apprenticeship and the basis for entrepreneurship.

Since teaching is a vocation, what is needed in the production of science teachers is more of training than teaching. Teaching will provide the knowledge but training will provide skills and competence. Teaching produces a **qualified teacher** but training produces a **trained teacher**. In Nigeria, all what is happening in all Universities and Colleges of Education is teaching not training. No wonder we have teachers who are not committed and competent. One of the most unfortunate

decisions of the federal government of Nigeria with respect to Teacher Education programme was the scrapping of Teacher's grade II institutions.

Yes, the standard there would not have met with the challenges of today but what stopped us from beefing up the curriculum of the Teacher Training colleges?

For years science has been taught at different levels in an unscientific way. As shown in the figure above, there should be a proper integration of science, education and the laboratory. In this interaction, the learner occupies a central position. That is, whatever is done, whether the consideration of the science concepts to be taught, teaching methods and the use of the laboratory and resources, adequate consideration should be given to the learners. It should be noted that without the learner there will be no need for the teacher.

I will now want to discuss the ordeal at various levels of science teaching.

5.0 The ordeal of Science Teaching

5.1 Primary Level

There has been a prolonged and painful experience in science teaching at this level. Prominent among these are:

✓ Dearth of Science Teachers

In Primary schools, there is no subject specialization. Every classroom teacher teaches all subjects including science whether or not he/she has any knowledge of science. The same goes for Mathematics. This is a serious set back because allowing for an improper foundation at that level has adversely affected the learners and science teaching in our society.

✓ High Pupils: Teacher Ratio

Another factor affecting science teaching and indeed, teaching generally at this level is the explosion in pupils' population without a corresponding increase in the number of teachers. In the first Akwa Ibom Education summit of 2006, I presented a research paper entitled "Quality Control: Issues and challenges in Akwa Ibom State Education System". In the course of research, I discovered staggering information with respect to pupils: Teacher ratio in Primary schools as at 2005 as shown in Table I.

As seen in Table 1, the only Local Government Area that had a normal pupil: teacher ratio then was Ikot Abasi (35:1). Eastern Obolo had the worst with 327:1. If this happened before the declaration of free and compulsory education, you can imagine what is happening today. With such, teaching cannot be effective and pupils leaving the primary school to secondary would have carried over problems in the form of gaps.

It was Martin Luther (1483-1546) who said concerning a teacher and teaching:

For you cannot teach an old dog new trick, and it is hard to reform old sinners, but this is what by preaching we undertake to do, and our labour is often spent in vain; but it is easy to bend and train young trees...

✓ Lack of Science Laboratories and Resources:

No meaningful science can be taught without resources and the laboratory (Anderson, 1972; Hirvonen, 2002; Ergin, 2005; & Ottander, 2006). The absent of the laboratory in the Primary school for science teaching has posed prolonged painful and horrific experience to science teachers and learners at this level. Although the natural resources abound within the school environment, because of lack of resourcefulness and interest on the part of some science teachers, they are hardly utilized (Jennings, 2005; & Akporehwe and Onwioduokit, 2010).

5.2 Secondary Level

The situation at this level differs slightly from the primary. Teachers with specialization in science subjects are available though not sufficient in number and not trained though qualified, especially in Akwa Ibom State schools where the percentage of graduate teachers is very impressive as shown in Table 2.

But the major ordeals here are:

- ✓ Improper grasps of the subject matter on the part of most science teachers (Onwioduokit, 1996; & Clough, 2003).
- ✓ Improper integration of the laboratory resources in science teaching. My work on the role of laboratory facilities on the cognitive development of Physics students in 1998 revealed that most school lack functional laboratories. Even in the few schools that facilities are available, they are hardly put to use. Most science teachers preferred teaching science without using the needed facilities. It should be mentioned here that the present paradigm of separating theory from practical is faulty. There is hardly any concept in science that does not require a practical demonstration. The study also revealed that science students were only exposed to practical work between two or three weeks to their external examination.
- ✓ Another problem of science teaching in secondary school is that of lack of commitment and discipline on the part of almost all the teachers. This amounts to lack of resourcefulness. A committed and resourceful science teacher should look for improvised materials to teach in the absent of the prototypes. This happens mostly in public schools where there is a high level of laissez-fare attitude.

5.3 Tertiary Level

The ordeal of science teaching at this level is not significantly different from the secondary level. Knowing that it is at this level that science teachers are required to be trained for both primary and secondary levels, there should be a great concern. This is because whatever gaps existed in the learner at the primary and secondary levels, cumulatively, should be bridged at the tertiary level of education. If this is not done, our graduates will go back to schools and create greater gaps in the

students. Prominently, the following situation still persists in science teaching at the tertiary level:

- A gap between the sciences taught to Science Education students and what they are expected to deliver after their training as science teachers. In the present paradigm all courses in science: Physics, Chemistry, Biology and Mathematics) are taught at the Faculty of Science. The department of Science Education teaches the methods and strategies as well as exposed the would-be science teacher to the knowledge of available and improvised resources for science teaching. The primary objective of Science Education is to produce people who are, literate in science. According to National Science Education standard, the scientifically literate person possesses the capability to:
- ✓ Understand experiment and reasoning as well as basic scientific facts and their meanings;
- ✓ Ask, find or determine answers to questions derived from curiosity about everyday experiences;
- ✓ Describe, explain and predict natural phenomena;
- ✓ Read with understanding articles about science in the popular press and to engage in social conversation about the validity of the conclusions;
- ✓ Identity scientific issues underlying national and local decisions and express positions that are scientifically and technologically informed;
- ✓ Evaluate the quality of scientific information on the basis of its source and the methods used to generate it; and
- ✓ Pose and evaluate arguments based on evidence and apply conclusions from such argument appropriately.

It should be noted that the present model of teaching science does not make for the production of scientifically literate individuals.

Over 50% of what the students are taught in the Faculty of

Science does not have a direct bearing with the secondary school curriculum that the products are expected to implement. It is true that the teacher should know more than the students but he/she must first know what the students need. Ausubels (1968) in Onwioduokit (1996) has it that learning should start from the most inclusive concept to the least. While this is true in few cases, most students find this order difficult. That is why Ansubel theory is not very popular in science teaching.

- Improper integration of theory and practicals. The dichotomy between theory and practicals still exists at the tertiary level. Most courses are taught without practical demonstrations. Even in the practical classes, only few students actually handle the apparatus to conduct the experiments, either because the facilities are few or the laboratory space is too small or both. The practice of group practicals should be discontinued especially for Science Education students.
- ✓ Non provision for entrepreneurial skills development. The fact that most graduates of higher institutions in Nigeria cannot secure employment is no news. There are two major reasons the Curriculum and its implementers. The curriculum in Science and Science Education should be drastically modified to provide for entrepreneurial skills acquisition.

However, whether for a new or present curriculum, implementation is crucial. For instance, insufficient provision for manipulative skills development, though provided for in the present curriculum through practicals and laboratory experiments, has brought a serious set back to learners.

6.0 The Aftermath of current practices in Science Teaching

- Consistent poor performance in external examinations
- ✓ Massive unemployment
- ✓ High level of indiscipline among students and teachers
- ✓ Prevalence of Examination Misconducts

These poor results show that there is something wrong with science teaching and learning. Many times people blame it on students. That they are dull, unwilling to learn, not attentive, absent from lectures, and all the like. Studies (Onwioduokit, 1996; Ivowi, 1999; & Ogunleye, 2003) have shown that the problems of fallen standard of Science Education (as well as others) go beyond students. Students are the products. It takes a good process to end up with a good product. Moreover, no matter how excellent the processes and the facilities used are, it is the product that justifies the process. For instance if a teaching or lecturing could not produce at least 60% success among the learners, it is not only the students that have failed, the teacher has also failed.

The failure of the teacher is seen in the area of improper preparation for the lesson, inconsistency in delivering lessons, non-integration practical demonstration, non-involvement of students in the teaching/ learning process, lack of passion for teaching, among others. We must not only think that the fault is only with the students. No child who has successfully passed through the primary school is a moron or imbecile. They have ability to learn if properly taught and attended to. Every student has something useful in his/her cognitive structure. What is needed is a skillful teaching capable of bringing about the restructuring of their cognitive frame work.

7.0 Some personal work done in Science Teaching
Let me now outline few of the personal works done in fostering
the teaching and learning of science with the view to prescribe
a new paradigm for the future generation.

7.1 At the Primary level

What I did at this level centered on the training of primary science teachers through seminars and workshops arranged by both government and private organizations. The core of the

training has been on **Teaching Primary Science in a primary** way (Onwioduokit, 2003,).

7.1.1 Using the concept of simple machine

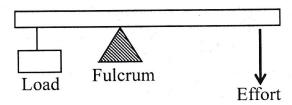
✓ Materials: claw hammer, kitchen knife, nut cracker, a pair of scissors, wheel barrow, sugar tongs, cap opener, wooden plank, nails cutter, bottles of Coca-Cola drink, cement block.

✓ Action:

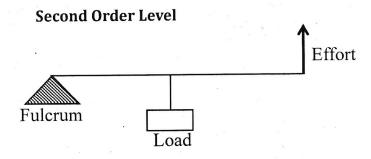
- A. The teacher stands in front of the class with the materials displayed and poses a challenge to the pupils thus:
- (i) Who can lift me up? "I want someone to lift me up". Using a play-way method, the teacher subjects himself/herself to pupils' attempts. The pupils are not likely to be successful, hopefully.
- (ii) The teacher now places the plank on the cement block and stands at the end of the shorter arm saying, "let someone lift me up". Standing at the end of the longer arm of the plank, a pupil is likely to lift the teacher. This will likely attract applause.
- (iii) The pupils are then made to identify the arrangement as a simple machine, and be guided to identify the Load (L), Fulcrum (F) and the Effort (E) in the arrangement as well as the direction each is acting and that this type is called a lever.
- B. Pupils' Activity.
- (i) Using a hammer, drive a nail far into the wood provided.
- (ii) Use your hand to remove the nail from the wood. What do you observe? Try again. Are you successful? Why?
- (iii) Now use a claw hammer to remove the nail. What have you noticed? Have you noticed the ease with which the

- nail is removed using the hammer? The hammer is a simple machine. It helps to do work faster and easier.
- (iv) Then guide the pupils to identify the Load (L), the Fulcrum (F) and the Effort (E).

C. Symbolic representation. First Class Lever

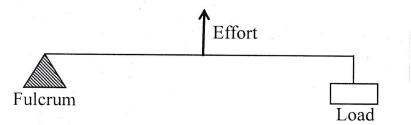


Their examples include: diggers, shovels, a pair of scissors, pliers, pump handles and steelyard.

Third Order Lever



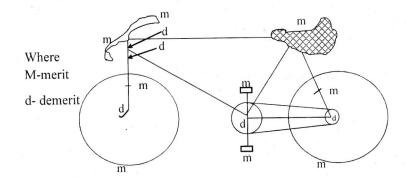
Examples include: sugar tongs, cap openers and table knives.

7.1.2 Concept 2: Friction

Here I came up with many pupils-oriented activities that are capable of enhancing their understanding of this concept to include:

- (i) Observing the soles of their shoes.
- (ii) Observing a used car tyres.
- (iii) Trying to walk on a slippery surface with a flat-sole shoe compared to walking on a rough surface.
- (iv) Attempting to cut something with a kitchen knife after washing clothes immediately.
- (v) Pounding okro and pepper, respectively.
- (vi) Rubbing two slices of dry or toasted bread.
- (vii) Rubbing a sand paper against a rough metal surface.
- (viii) Rubbing their palms vigorously, together and immediately touching their cheeks with them.
- (ix) Rubbing the pebble against a cement floor.
- (X) Striking a match
- (xi) Striking the sharp edge of a cutlass against a stone or cement floor and noting the results.

In each of the activities pupils are guided to discuss their experiences, identifying the merits and demerits of friction. I then use d a bicycle to illustrate the merits and the nuisance (demerits) of friction.

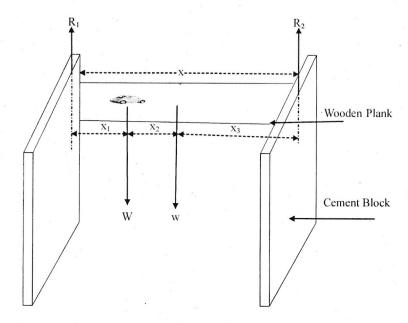


Model of a bicycle showing locations of merits and demerits (nuisance) of friction

7.2 At Secondary level

7.2.1 Using Models

Since the role of models in the process of teaching and learning science is receiving increasing attention, I also used models in teaching physics at the secondary school level. Among this was a model of a bridge using two cement blocks vertically placed at a distance X apart. Then a wooden plank on the blocks such that the two edges of the plank rests on each block.



Model of a bridge with a car of weight, W.

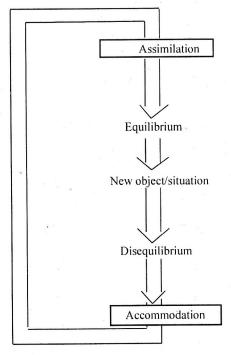
This model was used in teaching quite a number of concepts in mechanics. It aided the teaching and conceptualization of "Action and reaction Forces", "Equilibrium of Forces", "Moment of Forces" and the "Principle of Moment".

7.2.2 Application of Psychological theories of relevance in Science Teaching.

Some fundamental theories that are directly applicable to the teaching and learning of science include:

- 1. Jean Piaget's (1896-1980)
 - ✓ Interested in the theory of cognitive development of children from the ages of zero to a little above 11 years. This mainly applies to children from preschool through the primary school age.
 - ✓ According to Piaget (1970), children learn best through doing and actively exploring their

- environment. By implication therefore science should be taught in such a way that children are occupied by useful activities and enabled to explore their natural environment.
- ✓ The concept of Assimilation via Disequilibrium and Accommodation is actually not only useful for children but also for adults in science teaching.



Piaget's model for effective teaching/learning.

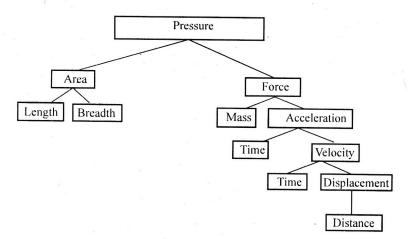
In summary, Piaget favours

- Child-centreness in the teaching process.
- The use of plays in teaching the children.
- Learning by discovery.
- The use of resources in the environment in teaching.

2. Robert Gragne (1916-2002)

Paramount in Gagne's learning theory is the concept of task analysis which emanates from his emphasis on prerequisite learning (Onwioduokit, 1996).

- * The major work of a science teacher in this will be to analyse the task to be taught to prerequisite tasks, arranging them hierarchically from the most inclusive to the least inclusive.
- * Then teaching should then be from the least inclusive to the most inclusive.
- * Guided classroom and laboratory is favoured by Gagne. Using the concept of pressure, the sequence is shown as below (Onwioduokit, 1996).



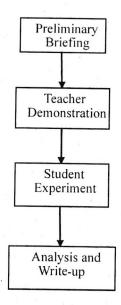
- 3. Constructivism as a paradigm in science teaching.
 - Simply this paradigm learning can only occur meaningfully when there is a restructuring of the learning cognitive structure as the result of seemingly contradictory information or object to be learnt.
 - That it is when this "confusion" occurs in the mind that

- the learner, in an attempt to resolve, will learn.
- That, teachers may need to purposefully present certain things that looks and sounds contradictory to the learners before guiding them to resolve the issue.
- For example, the teacher may purposefully reject the first correct answer to a question given by the student.

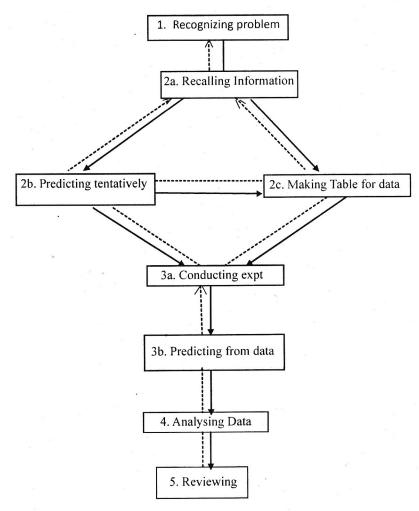
David Ausubel (1918-2008) belongs to this group with his concept of Subsumption theory where a new material must be subsumed by a subsumer or an advance organizer (in the absence of appropriate subsumer) for meaningful learning to occur. In the process of this subsumption, there is a restructioning of the cognitive framework.

7.7.3 Development of laboratory problem solving model Considering the "cookbook" nature of practicals in secondary school system, I was interested in developing a model for use at the level which could be applied at the tertiary level. It is called Laboratory Problem-Solving Model (LAPSOM).

Traditional Laboratory pattern for practicals

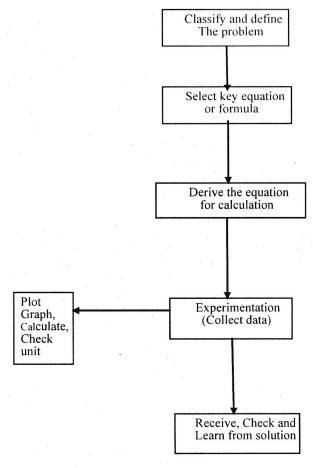


Laboratory problem-solving model (LAPSOM)

To test the effectiveness of the model (LAPSOM), I brought in the modified Selvanantnam-Frazer Model (1982)

The relative effectiveness was measured with respect to the following skills known as laboratory skills (Onwioduokit, 1993, 2003):

1. Cognitive skills

- Manipulative skills
- Observational skills
- Computational skills and

7.3 At the Tertiary level

My contributions to science teaching at the tertiary level has been in the areas of research and the teaching the would-be science teaching on how to teach concepts branded difficult, particularly, in Physics Education (Onwioduokit, 1996; Onwioduokit and Mkpanang, 2001).

- Improvisation of materials in the teaching of physics (Onwioduokit, 1998; Onwioduokit, Akinbola and Udo, 2008; Onwioduokit, 1997, 1998; Onwioduokit and Efut, 2000, 2010).
- Determining the predictors of students' performances in Science learning (Onwioduokit, 1999; Onwioduokit and Utibe, 2003, 2004; Onwioduokit and Mkpanang, 2005).
- Assessment of the effects of teaching and learning science (Onwioduokit, 1992, 1993, 1995, 1998, 1998a, 2002, 2007, 20011).

7.3.1 The use of local materials in teaching Physics.

 Determination of tensile strength and stiffness of local ropes (piassava and tie-tie) when in a dry and dampened states. This was published in Alberta Science Education Journal in 1998.

Theory

To obtain the tensile strength and stiffness (Young's modulus) of each material, the following expressions were used:

- 1. Tensile strength = <u>Maximum force applied before the material breaks</u>
 Original cross sectional area
- 2. Stiffness = Tensile stress Tensile strain

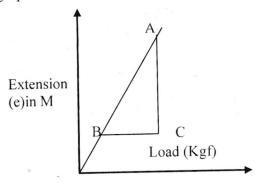

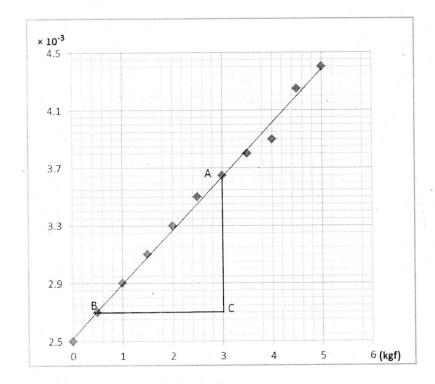

The results obtained from the experiments are given as follows.

Graph 1

A plot of extension (e) against force applied (F) using a dampened piassava (DAP-1) of length (L_1) 0.805m and mean diameter (r_1) 7.42 × 10⁻³m. Breaking stress = 5.00Kgf

Graph 1 yields the slope $3.87 \times 10^{-5} \text{MN}^{-1}$. The reciprocal of the slope is therefore $2.58 \times 10^4 \text{NM}^{-1}$. Based on this, the following calculations are made:

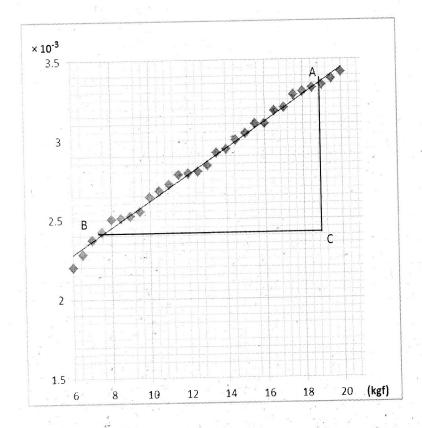

From Graph 2, the slope is $8.29 \times 10^4 \text{NM}^{-1}$, giving a reciprocal of $1.21 \times 10^5 \text{NM}^{-1}$. Consequently, the following results are obtained:

- 1. Tensile strength of dampened piassava (Dap-2), $TS_2 = 8.66 \times 10^6 \text{NM}^2$
- 2. Young's modulus (E_2), $E_2 = 5.04 \times 10^9 \text{NM}^{-2}$ From these values of tensile strengths and young moduli, the mean values can be calculated for a dampened piassava thus:
- 1. Tensile strength of dampened piassava:

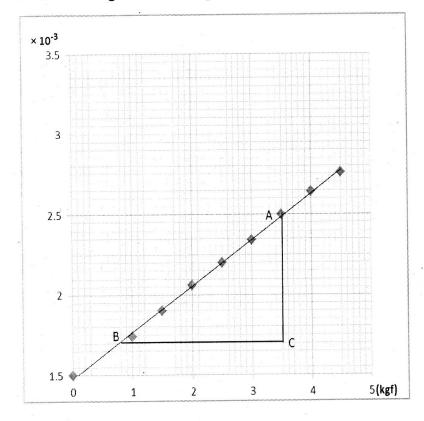

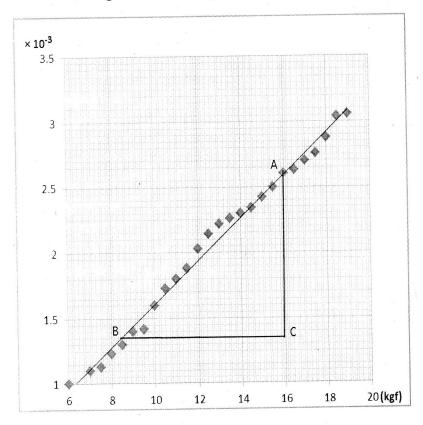

- 2. Young's modulus (E₄) of dry piassava = $3.22 \times 10^{9} \text{Nm}^{-2}$

Considering calculations based on graphs 3 and 4, the mean values for dry piassava are:

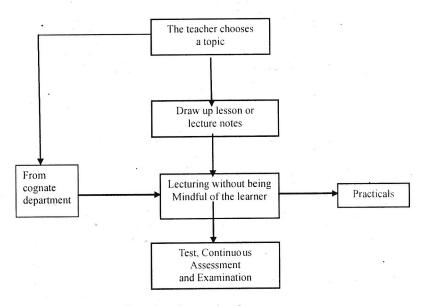

Similarly, graphs for extension versus force applied can be made for dry tie-tie (hard), dry tie-tie (soft), dampened tie-tie (hard) and dampened tie-tie (soft). The results are summarized in Table 1.

8.0 The need for a paradigm shift

The present paradigm has brought about:

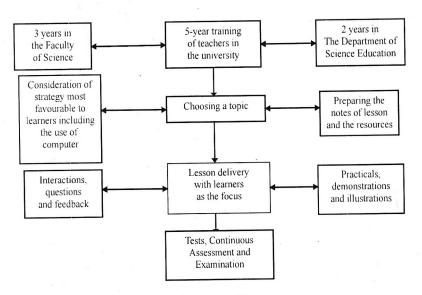
- Poor understanding, comprehension and application of science concepts by learners.

If we must address the problems of science teaching with the attendant unfavorable consequences, science teaching

revolution is needed. This must start from the training of science teachers (those that are both scientists as well as teachers). After scrapping the Teacher Training Colleges what is being embarked upon now is teacher qualification and not teacher training.

9.0 The New Paradigm

- ✓ In-built processes for the training of science teachers
- ✓ Integration of theory with practical
- ✓ learners as being central in the teaching process
- ✓ 5-year undergraduate training for science teachers:
- First 3 years at the Faculty of Science
- The last two years in the Department of Science Education to cover hands-on training on all science concepts the students are expected to teacher after graduation as well

one full year of closely monitored and supervised teaching practice

The new paradigm is expected to work with:

- Proper attitude of teachers
- Close supervision of the Heads of Departments with respect to regularity and promptness to work and the quality of lesson delivery.
- The school or university authority regulating the use of cell phones among students during lecture periods 8.00am 5.00pm
- 75% attendance policy should be strictly enforced.

10.0 CONCLUSION

Science Education is the basis for scientific and technological development of any country. The quality of science teachers and teaching therefore is very crucial to national development. The science teacher needs to possess both adequate knowledge of science and teaching skills, coupled with good attitude to work.

There are quite a number of challenges. The problems have lingered for years and it is time they should be tackled if we must make it technologically and economical, for actualization of Vision 20-2020. It is my candid opinion that the poor performances of students and their involvement in examination misconducts as well as the high level of unemployment can be overcome with learner-centered teaching and the proper use of laboratory and the resources available or improvised.

There is therefore a need for a shift in science teaching paradigm.
